Identity and Statement of Educational Purpose (Signed in person at the Institution)

The student must appear in person at <u>**MISERICORDIA UNIVERSITY - FINANCIAL AID OFFICE**</u> to verify his or her identity by presenting an unexpired valid government-issued photo identification (ID), such as, but not limited to, a driver's license, other state-issued ID, or passport. - (b) The original Statement of Educational Purpose provided below, which must be notarized. If the notary statement appears on a separate page than the Statement of Educational Purpose, there must be a clear indication that the Statement of Educational Purpose was the document notarized.

In addition, the student must sign, in the presence of a notary, the below Statement of Educational Purpose.
